1 Description of the building product

PVC-foil with polymer plasticizers and with an acrylate-based adhesive coating on one side; the PVC-foil is deliverable with different surface structures.

Thickness of the foil without the self-adhesive coating: 0.08 mm \pm 20 % Thickness of the foil with the self-adhesive coating: 0.105 mm \pm 20 % Mass per unit area of the foils with fine structure: app. 116 g/m² Mass per unit area of the foils with coarse structure: app. 104 g/m²

Colours: silver and gold
